Approved 2002/03 Operating Budget.

RECOMMENDATIONS

It is recommended that Council

1. award Tender No. 02-030 Asphalt Patching, West Region, to Dexter Construction Co. Ltd. for materials and services listed at the unit prices quoted for a Tender Price of \$285,640, plus net HST for a total of \$304,004 from Operating Account R731-6399, Patching, Contract Services, with funding authorized as per the Budget Implications section of this report.

- 2. award Tender No. 02-050, Asphalt Patching, East Region, to Lafarge Canada Inc. for materials and services listed at the unit prices quoted for a Tender Price of \$178,800, plus net HST for a total of \$190,295 from Operating Account R731-6399, Patching, Contract Services with funding authorized as per the Budget Implications section of this report.
- 3. award Tender No. 02-035 Asphalt Patching, Central Region, to Lafarge Canada Inc. for materials and services listed at the unit prices quoted for a Tender Price of \$179,200, plus net HST for a total of \$190,291 from Operating Account R731-6399, Patching, Contract Services with funding authorized as per the Budget Implications section of this report.

BACKGROUND

The approved 2002/03 Operating Budget includes funds for patching of HRM streets within the Urban Core Boundary of the Halifax Regional Municipality.

DISCUSSION

Tenders were called on May 8, 2002, and closed on May 23, 2002. The following bids, exclusive of taxes, were received:

These tenders include the asphalt patching by hand and by cut and patch, of existing HRM streets and roadways within the Urban Core Boundary. The patching work is demand in nature and the overall amount of work exceeds what can be accomplished with the approved budget for street

patching. The tenders used estimated quantities to establish **UNIT PRICES** and will enable staff to maximize the units completed within the approved budget allotment.

It is anticipated that work will commence within three weeks of the tender award and continue for a period of approximately eight weeks.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

BUDGET IMPLICATIONS

Based on the lowest tendered prices totalling \$643,640, plus net HST for a total of \$685,020, funding is available in the 2002/03 Approved Operating Budget under Operating Account No. R731-6399 Patching - Contract Services. The budget availability has been approved by Financial Services.
