## **ORIGIN**

Approved 2002/03 Capital Budget.

#### **RECOMMENDATION**

It is recommended that Council award Tender No. 02-230, Sidewalk Renewals - West Region to Ocean Contractors Limited for materials and services listed at the unit prices quoted for a Tender Price of \$118,980., plus net HST for a total of \$126,629. from Account No. CKU00141, Sidewalk Renewals, with funding authorized as per the Budget Implications section of this report.

#### BACKGROUND

The 2002/03 Approved Capital Budget includes funds for the renewal of sidewalks within the Halifax Regional Municipality.

#### **DISCUSSION**

Tenders were called on May 1, 2002, and closed on May 17, 2002. The following bids, exclusive of taxes, were received:

The scope of work for this tender includes the replacement of the existing concrete curb and gutter and existing concrete sidewalk with new concrete curb and gutter and new concrete sidewalk which are included in the approved budget on Bayers Road (S) from George Dauphinee Avenue to Connaught Avenue, Lloyd Fox Avenue (W) from Edward Arab Avenue to the end, Melton Avenue (S) from Lexington Avenue to Morningside Drive and Mumford Road (W) from West End Exit to Sears Entrance - West Region.

It is anticipated that work will commence within three weeks of the tender award.

This is a **UNIT PRICE** contract and the cost will be dependant upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

#### **BUDGET IMPLICATIONS**

Based on the lowest tendered price of \$118,980.00, plus net HST for a total of \$126,629., funding is available in the 2002/03 Approved Capital Budget under Account No. CKU00141, Sidewalk Renewals. The budget availability has been approved by Financial Services.
