## **ORIGIN**

## **RECOMMENDATION**

It is recommended that Council award Tender No. 02-245, Sidewalk Renewals - East Region to B & L Contracting Limited for materials and services listed at the unit prices quoted for a Tender Price of \$222,692.50 plus net HST for a total of \$237,010. from Account No. CKU00141, Sidewalk Renewals, with finding authorized as per the Budget Implications section of this report.

## **BACKGROUND**

The 2002/03 Approved Capital Budget includes the replacement of concrete sidewalks because of their overall poor condition.

## **DISCUSSION**

Tenders for this project were called on May 11, 2002 and closed on May 23, 2002. The following bids, exclusive of taxes, were received:

1.	B & L Contracting Limited	\$222,692.50
2.	Ocean Contractors Limited	\$233,380.00
3.	Dexter Construction Company Ltd.	\$296,551.50
4.	Precision Concrete Services Limited	\$472,520.00

The scope of work for this tender includes the renewal of concrete sidewalk, concrete curb and gutter and sodding at the locations listed below:

Elliot Street (E) - Erskine Street to Prince Albert Road Pleasant Street (N) - Erskine Street to Portland Street Pleasant Street (S) - Prince Albert Road to Portland Street Pleasant Street (W) - Tupper Street to Boundary Street Prince Albert Road (S) - Ochterloney Street to Elliot Street

It is anticipated that work will commence within three weeks after award of tender.

This is a **UNIT PRICE** contract and the cost will be dependant upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

## **BUDGET IMPLICATIONS**

Based on the lowest tendered price of \$222,692.50 plus net HST for a total of \$237,010., funding is available in the 2002/03 Approved Capital Budget under Account No. CKU00141, Sidewalk Renewals. The budget availability has been approved by Financial Services.
