## **ORIGIN**

Approved 2002/03 Capital Budget.

## **RECOMMENDATION**

It is recommended that Council award Tender No. 02-251, Paving Resurfacing - East Region to Ocean Contractors Limited for materials and services listed at the unit prices quoted for a Tender Price of \$322,015., plus net HST for a total of \$342,717. with funding from Account No. CZR00357, Resurfacing with funding authorized as per the Budget Implications section of this report.

The 2002/03 Approved Capital Budget includes funds for the resurfacing of streets within Halifax Regional Municipality for the purpose of extending the life of the road structure and to reduce maintenance costs and significantly improve the level of service to the public.

### DISCUSSION

Tenders for this project were called on May 4, 2002 and closed on May 17, 2002. The following bids, exclusive of taxes, were received:

3.	Lafarge Canada Inc.	\$513,352.17
4.	Basin Contractors Limited	\$636,317.50

The scope of work for this tender includes resurfacing of asphalt pavement on Eastern Passage Road between Hines Road and Norah Lane - East Region.

Staff has reviewed the scope of work and carried out further investigations of site conditions. It has been determined that the quantities of materials can be reduced without compromising the overall quality of the project. The low bidder has agreed to carry out the work on the reduced quantities at the unit prices quoted for a price of \$322,015. plus net HST.

It is anticipated that construction will commence within three weeks after the award of tender.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

#### **BUDGET IMPLICATIONS**

Based on the tender price of \$322,015. from Ocean Contractors Limited, plus net HST for a total of \$342,717. funding is available in the 2002/03 Approved Capital Budget under Account No. CZR00357, Resurfacing. The budget availability has been approved by Financial Services.
