Profit Organizations (2002-2003): Amendment to Recommendations

#### SUPPLEMENTARY REPORT

## **ORIGIN**

At the Regional Council meeting of April 23rd, 2002, staff were asked to conduct a further review of two applicants under By-law T-209. Specifically, Councillor Keith Colwell asked that a meeting be arranged with representatives of Chezzetcook and District Lions Club, 89 Chezzetcook Road (See page 2, Item A.1) regarding the intended use of their facility for recreational purposes. Councillor Gary Meade asked staff to meet with representatives of Coastal Communities Economic Development Co-operative Limited (See page 10, Item B.4).

Staff have conducted site visits, met with representatives and received additional documentation from both parties. On the basis of this information staff made recommendations to the HRM Grants Committee at their meeting of May 6th, 2002.

### **RECOMMENDATION**

It is recommended that Regional Council approve the following amendments to By-law T-209:

- 1 That Chezzetcook and District Lions Club, 89 East Chezzetcook Road, be awarded 100% tax exemption on the basis of the provision of a facility for recreational programming in cooperation with HRM Parks & Recreation and local community groups.
- 2. That the case of Coastal Communities Economic Development Co-Operative Limited be withdrawn from By-law T-209 for further review and consideration by the Grants Committee. This case will be brought forward in 2002-2003 fiscal year in a subsequent report to Regional Council under By-law T-201.

### BACKGROUND

#### 1. Chezzetcook and District Lions Club.

Subsequent to the request for further documentation, staff met with representation from the Lions Club on April 30th. The Club has provided written verification from Frances Matheson, Area Coordinator, HRM Parks & Recreation detailing the intended cooperative access to the facility located at 89 East Chezzetcook Road to deliver recreation programming at the site, as well as potential trail-head amenities to serve the Trans Canada Trail. The community centre is also expected to provide meeting space for local groups, a social venue, and affordable rental space for receptions and events. A site visit was made by staff on April 25th, 2002.

On the basis of the provision of a community-owned and operated facility for recreational programming, the Lions Club are providing a service that might otherwise be an expense to the municipality.

2. Coastal Communities Economic Development Co-Operative Limited.

A meeting with representatives from the Co-Operative was held May 1st at which time a revised business plan was submitted. It was agreed that staff would request the case be withdrawn from the By-law T-209 report pending a further review of the business plan, financial statement, development agreement, and tax status of the Co-Operative. The application will still be considered in fiscal year 2002-2003. In the interim, Financial Services have agreed to suspend any tax sale proceedings pending completion of the review.

## **DISCUSSION**

Both community groups have undergone changes in the leadership of their respective organizations. It is important that each feels they have had appropriate and sufficient opportunity to represent their case to HRM. Both applicants will be sent a copy of this supplementary report and will be notified, along with all other applicants to the By-law, of the public hearing June 11th, 2002.

#### **COMMUNITY IMPACTS**

In the case of the Chezzetcook and District Lions Club, the development of a community centre to serve the recreational and social interests of local residents will enhance accessibility, affordability, and participatory opportunities. Collaborative ventures with the West Chezzetcook and Grand Desert Community Interest Group for the development of an extended Trans Canada Trail route and a trail-head facility, the local historical society, and youth groups should enhance community relations.

A delay in a determination of the Coastal Communities Economic Development Co-Operative application seems warranted given the substantive re-organization outlined in the revised business plan. Further details regarding shareholder's equity will be provided to the Grants Committee. Staff anticipate a further presentation by the organization to the Committee at a future date.

#### **BUDGET IMPLICATIONS**

If approved by Regional Council, an increased tax subsidy to the Chezzetcook and District Lions Club of 100% exempt will add \$1,607 to the estimated cost of this year's program.
