SUBJECT: **By-Law Number L-104, Respecting Local Improvement Charges -
Cow Bay Road Sewer and Water**

ORIGIN

HRM Council Meeting of April 9, 2002 approving the staff recommendation providing funding for the removal of first lateral charges.

RECOMMENDATION

It is recommended that Halifax Regional Council:

Approve, in principle, By-law L-104 and begin the formal adoption process.

BACKGROUND

At the April 9, 2002 meeting of Halifax Regional Council approval was granted for the funding of \$43,200 for Capital Account No. CSU00379, Eastern Passage, Cow Bay Water and Sewage from account Crespool to cover the reduction from outside funding due to a reduction in the bulk land charge and the removal of the first lateral charge levied on properties under the Cow Bay Sewer and Water Local Improvements, By-Law 101.

DISCUSSION

Until such time as Council approved the funding source for the reduction from outside funding, staff were unable to proceed through the process to amend the original By-Law L-101 and complete adjustments to property owner accounts. The proposed By-Law L-104 deletes all reference to the lateral charge from the main to the property line and amends the charge rate for the bulk land component to \$1,848 from \$2,100 per acre, which was approved by Council on September 25, 2001.

BUDGET IMPLICATIONS

There are no further budget implications. Council has approved funding of \$43,200 for Capital Account No. CSU00379, Eastern Passage, Cow Bay Water and Sewage from account Crespool on April 9, 2002.



BY-LAW NUMBER L-104

RESPECTING CHARGES FOR LOCAL IMPROVEMENTS

BE IT ENACTED by the Council for the Halifax Regional Municipality that By-Law Number L-101, the Local Improvement By-law, be amended as follows:

1. Clause (a) of that part of Schedule "A" entitled "Cow Bay Road Area Sewer and Water Extension" is amended by deleting the words "plus a charge of \$1,350. for each water and sewer lateral from the main to the property line." as it appears on the fourth and fifth line thereof.
2. Clause (b) of that part of Schedule "A" entitled "Cow Bay Road Area Sewer and Water Extension" is amended by deleting the figure "\$2,100." as it appears in the third line thereof and substituting therefore the figure "\$1,848."

BY-LAW NUMBER L-101

RESPECTING CHARGES for LOCAL IMPROVEMENTS

BE IT ENACTED by the Council of the Halifax Regional Municipality that By-Law Number L-100, the Local Improvement By-Law is hereby amended as follows:

1. Schedule "A" of By-Law Number L-100 is amended by adding the following:

Cow Bay Road Area Sewer and Water Extension

a) The Local Improvement Charges for properties fronting or abutting in whole or in part, on Cow Bay Road, in the area identified on the plan "Cow Bay Road Area, Sewer and Water Extension, Plan No. 1, dated August 5, 1998," shall be \$65. per lineal foot of frontage plus a charge of \$1,350. for each water and sewer lateral from the main to the property line.

b) The Local Improvement Charges for properties identified on the plan "Cow Bay Road Area, Sewer and Water Extension, Plan No. 2, dated August 5, 1998," shall be \$2,100. per acre of area.

c) The Local Improvement Charges for the property identified on the plan "Cow Bay Road Area, Sewer and Water Extension, Plan No. 3, dated August 5, 1998" shall be \$12,000.
