Sidewalk Renewal, Edinburgh Street - West Region

ORIGIN

Approved 2002/03 Capital Budget.

RECOMMENDATION

It is recommended that Council award Tender No. 02-294, Paving Resurfacing and Sidewalk Renewal, Edinburgh Street- West Region to Dexter Construction Company Limited for materials and services listed at the unit prices quoted for a Tender Price of \$181,240 plus net HST for a total of \$192,892 from Account Nos. CKU00141, Sidewalk Renewals, and CZR00357, Resurfacing, with funding authorized as per the Budget Implications section of this report.

BACKGROUND

The 2002/03 Approved Capital Budget includes funds for a paving renewal program and for the replacement of concrete sidewalks because of their overall poor condition within the Halifax Regional Municipality.

DISCUSSION

Tenders were called on September 14, 2002 and closed on September 24, 2002. The following bids, exclusive of taxes, were received:

The scope of work for this tender includes the resurfacing of Edinburgh Street from Connaught Avenue to Oxford Street, with new asphalt pavement and gravels. It also includes the renewal of the concrete sidewalk and concrete curb and gutter on the north side only between Connaught Avenue and Connolly Street.

It is anticipated that work will commence within two weeks of the tender award.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

BUDGET IMPLICATIONS

Based on the lowest tendered price of \$181,240 plus net HST for a total of \$192,892, funding is available in the 2002/03 Approved Capital Budget under Account Nos. CKU00141, Sidewalk Renewals and CZR00357, Resurfacing. The budget availability has been approved by Financial Services.
