ORIGIN

Regional Council Meeting of August 20, 2002, item 13.3 Property Matter: Bayers Lake Business Park Interchange Improvements and September 24, 2002, item 9.2.6, Cost Sharing Agreement - Provincial Department of Transportation and Public Works and HRM re: Highway 102 Interchange Upgrading.

RECOMMENDATION

It is recommended that Council award Tender No. 02-296, Lacewood Drive Upgrades: Phase 1 - West Region to J. R. Eisener Contracting Limited for materials and services listed at the unit prices quoted for a Tender Price of \$360,520 plus net HST for a total of \$383,698 from Account No. CQ200414, Business Parks - Major Intersection Improvements and CJR00956, New Sidewalks, with funding authorized as per the Budget Implications section of this report.

Council Report - 2 - October 8, 2002

BACKGROUND

At the Halifax Regional Council meeting of August 20, 2002, Regional Council approved proceeding with the implementation of upgrades for the Lacewood Drive entrance to the Bayers Lake Business Park.

The project involves the widening of Lacewood Drive, the widening of interchange ramps and the extension of the concrete sidewalk on the south side of Lacewood Drive to connect with the concrete sidewalk on Chain Lake Drive. Due to extended delivery times on traffic signal equipment, land acquisition and utility infrastructure relocations, the work will be tendered in two phases. Phase 1 will include construction of a retaining wall, concrete sidewalk, concrete curb and gutter, asphalt paving adjacent to the new curb and associated storm drainage improvements. Phase 2 will be for the remaining components of the overall project and be tendered later this fall.

DISCUSSION

Tenders for Phase 1 were called on September 21, 2002 and closed on October 3, 2002. The following bids, exclusive of taxes, were received:

1. J. R. Eisener Contracting Limited	\$360,520.00
2. Dexter Construction Company Limited	\$388,071.00
3. Ocean Contractors Limited	\$423,110.00

Arrangements will be made to commence the work immediately following the tender award.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

BUDGET IMPLICATIONS

Based on the lowest tendered price of \$360,520 from J. R. The budget availability has been approved by Financial Services.
