SUBJECT: Award Tender 02-155 Knightsridge Fire Station Renovations

ORIGIN

Approved 2002/03 Capital Budget.

RECOMMENDATION

It is recommended that Council:

Award Tender 02-155 to Cardinal Construction Incorporated, for a Tender price of \$398,900, plus net HST for a total of \$424,546 from Capital Account CBF00036 Knightsridge Dr. Station 7 Repairs, with funding authorized as per the Budget Implications section of this report.

BACKGROUND

Problems identified with the exterior brickwork, roof and interior finishes of Station # 7, 45 Knightsridge Drive led to detailed investigations of the building condition. The results of these investigations noted a number of serious structural and building envelope problems at this location, including a failed roofing system, water damaged roof sheathing and insulation, and brick repairs. The investigations also identified mold growth in ceiling systems resulting from roof leaks. In order to protect staff from potential risk of exposure from the mold the effected materials were removed late in 2001, leaving the building without proper insulation in the ceiling. The building remained in this condition throughout the winter of 2001/02 while funding was approved in the 2002/03 Capital Budget. To accommodate this reduced capacity of the station some apparatus and staff were temporarily located to other nearby stations. These repairs will allow the building to return to its full function. At no time during this period was fire service to the local communities compromised.

DISCUSSION

The following bids were received on August 16, 2002

A reduction in the scope of work subsequent to tender opening has reduced the value of the work to \$398,900 before taxes (\$424,546 incl. net taxes) as noted in the Recommendations section of this report.
