Award of Unit Price Tender No. 02-290 Portobello Road (Highway #118 Overpass to Civic No. 1394), Paving Resurfacing - East Region

ORIGIN

Approved 2002/03 Roads and Streets Capital Budget.

RECOMMENDATION

It is recommended that Halifax Regional Council award Tender No. 02-290, Portobello Road (Highway #118 overpass to civic no. 1394), Paving Resurfacing - East Region to Lafarge Canada Inc. for materials and services listed at the unit prices quoted for a Tender Price of \$168,960, plus net HST for a total of \$179,822 from Account No. CZR00357, Resurfacing, with funding authorized as per the Budget Implications section of this report.

BACKGROUND

The 2002/03 Approved Capital Budget includes funds for a paving resurfacing program that will significantly improve the level of service to the public.

DISCUSSION

Tenders were called on August 10, 2002 and closed on August 23, 2002. The following bids, exclusive of taxes, were received:

1.	Lafarge Canada Inc.	\$168,960.00
2.	Ocean Contractors Limited	\$195,740.00
3.	Dexter Construction Company Limited	\$220,660.00
4.	Basin Contracting Limited	\$225,000.00

The scope of work for this tender includes milling and resurfacing of the existing asphalt pavement and replacing pavement markings on Portobello Road between Highway #118 Overpass to civic no. 1394.

It is anticipated that work will commence within three weeks of the tender award.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

BUDGET IMPLICATIONS

Based on the lowest tendered price of \$169,960, plus net HST for a total of \$179,822.44, funding is available in the 2002/03 Approved Capital Budget under Account No. CZR00357, Resurfacing. The budget availability has been approved by Financial Services.
