INFORMATION REPORT

ORIGIN

This Report originates from a work plan for the review of By-law B-300 which was presented to Regional Council on November 26, 2002 (status sheet item #7.1).

BACKGROUND

In November, 2002, a work plan was presented to Council which outlined the steps which would be followed to review the Blasting By-law. The original work plan was as follows:

Task 1. Research

Completed

Research other jurisdictions for legislation, threshold limits, etc.

Task 2. Consultation & Education

February, 2003

Industry Focus Group, Public Focus Group, and Council

Task 3. By-law Amendments

February - March, 2003

Recommendations to Council & Conduct Public Hearing

Stakeholder consultation is taking longer than expected, and the purpose of this report is to provide an update of the status of the by-law review.

DISCUSSION

Work which has been completed to date is summarized below.

Research

• As previously indicated to Council, a comprehensive review and analysis of other jurisdictions across North America is completed.

Industry Consultation

- Consultation with a Blasting Industry Focus Group has been completed. It is expected that one additional meeting will be required when the By-law amendments are drafted.
- The group consists of representatives from the Urban Development Institute, NS Home Builders Association, NS Road Builders Association, NS Construction Association, and the NS Mineral Aggregates Association.
- The Industry Group also contained representatives from the Nova Scotia Provincial Departments of Environment and Labour, and Transportation & Public Works.
- It should be noted that the Province of Nova Scotia is also reviewing the General Blasting Regulations, and care must be taken to ensure that the HRM By-law is consistent with the new Provincial Regulations. A review of both Provincial and Municipal regulations has been jointly completed by staff of HRM and the NS Department of Environment & Labour.

Public Consultation

- A Citizen's Focus Group is taking longer than expected to assemble. At the time of writing this report, meetings have not yet begun.
- The review is however not being delayed by the lack of participation in the Citizen's Focus Group. By-law amendments are being drafted, and a presentation to Council is being prepared which is aimed at educating Council prior to bringing recommendations forward.

Remaining Steps

• Complete Citizen's Focus Group March - April, 2003

• Council Education April 1, 2003

• Presentation of Draft By-law to Council April 29, 2003
