

ORIGIN

Request from the Waterfront Development Corporation Limited to close a portion of the former South or Boggs Street, Dartmouth.

RECOMMENDATION

It is recommended that:

1. Halifax Regional Council authorize staff to set a date of June 10, 2003, for a public hearing for consideration of HRM Administrative Order SC-29 concerning the closure of a portion of the former South or Boggs Street, Dartmouth, as shown on Attachment "A," based on the key terms and conditions outlined in this report.




