SUBJECT: Award of Unit Price Tender No. 03-234, Paving Resurfacing,

Gourok Avenue and Tupper Street - East Region

## **ORIGIN**

Approved 2002/03 and 2003/04 Capital Budgets.

## **RECOMMENDATION**

It is recommended that Council award Tender No. 03-234, Paving Resurfacing, Gourok Avenue and Tupper Street - East Region to Ocean Contractors Limited for materials and services listed at the unit prices quoted for a Tender Price of \$357,320, plus net HST for a total of \$380,292 from Account No. CZR00357, Resurfacing, with funding authorized as per the Budget Implications section of this report.

## **BACKGROUND**

The 2002/03 and 2003/04 Approved Capital Budgets includes funds for a paving resurfacing program that will significantly improve the level of service to the public.

## **DISCUSSION**

Tenders were called on April 16, 2003 and closed on May 1, 2003. The following bids, exclusive of taxes, were received:

3.	Dexter Construction Company Limited	\$402,000.00
4.	Basin Contracting Limited	\$473,530.00

The scope of work for this tender includes the resurfacing of the asphalt pavement on Gourok Avenue from Civic 58 to Culrain Crescent and Tupper Street from Pleasant Street to Harbour Drive.

It is anticipated that construction will commence within three weeks of the tender award.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

#### **BUDGET IMPLICATIONS**

Based on the lowest tender price of \$357,320 plus net HST for a total of \$380,292, funding is available in the 2002/03 and 2003/04 Approved Capital Budgets under Account No. CZR00357, Resurfacing. The budget availability has been approved by Financial Services.
