SUBJECT: Award of Unit Price Tender No. 03-235, Paving Resurfacing, Eastwood

Court, Ross Road and Ashgrove Avenue - East Region

## **ORIGIN**

Approved 2002/03 and 2003/04 Capital Budgets.

## **RECOMMENDATION**

It is recommended that Council award Tender No. 03-235, Paving Resurfacing - East Region to Dexter Construction Company Limited for materials and services listed at the unit prices quoted for a Tender Price of \$359,640, plus net HST for a total of \$382,762 from Account No. CZR00357, Resurfacing, with funding authorized as per the Budget Implications section of this report.

## **BACKGROUND**

The 2003/04 Approved Capital Budgets includes funds for a paving resurfacing program that will significantly improve the level of service to the public.

#### **DISCUSSION**

Tenders were called on April 17, 2003 and closed on April 29, 2003. The following bids, exclusive of taxes, were received:

3.	Lafarge Canada Inc.	\$404,700.00
4.	Basin Contracting Limited	\$470,149.75

The scope of work for this tender includes planing and patching of the existing asphalt surface, followed by an overlay of hot mix asphalt. Resurfacing is part of an annual program of street upgrading to reduce maintenance costs and extend the life of the road structure. Allowances have been made to upgrade, where applicable, asphalt curb to concrete curb.

It is anticipated that work will commence within three weeks of the tender award.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

#### **BUDGET IMPLICATIONS**

Based on the lowest tender price of \$359,640 plus net HST for a total of \$382,762, funding is available in the 2003/04 Approved Capital Budgets under Account No. CZR00357, Resurfacing. The budget availability has been approved by Financial Services.
