SUBJECT:

Appointment of the Traffic Authority

ORIGIN

Under the Halifax Regional Municipality Act section 130 (2) Council must appoint the Traffic Authority by Administrative Order.

RECOMMENDATION:

It is recommended that Council approve the amendment to Administrative Order Number 12 to reflect the appointment of Mr. Rick Paynter, P. Eng., as the Traffic Authority on an interim basis.

BACKGROUND

On January 27, 2003 David McCusker, P.Eng. accepted a secondment position with the Regional Planning project. This left the Manager of Traffic and Transportation Services and also the role of Traffic Authority vacant. Taso Koutroulakis, P.Eng. assumed the role of Acting Manager, Traffic and Transportation Services and Acting Traffic Authority on an interim basis.

DISCUSSION

Mr. Koutroulakis is currently the Deputy Traffic Authority. As Mr. Koutroulakis is scheduled for a three week vacation beginning August 29, 2003, it is recommended that Council approve the amendment to Administrative Order Number 12 to reflect the appointment of Mr. Rick Paynter, P.Eng. as the Traffic Authority.
