INFORMATION REPORT

ORIGIN

There is the need to establish a Community Liaison Committee for Herring Cove through a public process as was completed for Halifax and Dartmouth in support of the Harbour Solutions Project.

BACKGROUND

The Harbour Solutions Project, as part of their Public Involvement and Information Program, will be establishing, through a public process, a Community Liaison Committee (CLC) in the Herring Cove area to:

- Consult residents and other local stakeholders to identify the issues, interests and priorities of the local community with respect to the STP and its integration into the community.
- Work with the Halifax Harbour Solutions team during the detailed design and construction stage and develop recommendations concerning the integration of the plant and associated lands into the community.
- Work with HRM to develop a plan to extend sewer and water services to Herring Cove using the balance of the Community Integration Fund, related to the Herring Cove Plant.
- Work with HRM and plant management to ensure that the Herring Cove plant meets community expectations during its operation.

Community Liaison Committees (CLC) have been established in the communities surrounding the Halifax and Dartmouth Sewage Treatment Plant (STP) sites. In the Dartmouth and Halifax communities, no community representative bodies existed; therefore, the CLC's were set up through a public process in those areas. To date, the Herring Cove Ratepayers Association has been acting as the Herring Cove CLC during the predesign stage to identify the issues, interests and priorities of the local community with respect to the STP and its integration into the community. There has been some concern as to the appropriateness of this arrangement because it is inconsistent with the CLC approach taken in Halifax and Dartmouth. Given the degree of infrastructure activity that will be taking place in the Herring Cove area as we proceed with the Harbour Solutions Project, there is a need for a CLC that is representative of the community and has been established through a public process.

DISCUSSION

As there is concern being expressed within the community of Herring Cove regarding the use of the Ratepayers Association as the CLC, it has been difficult to move forward with the work that is expected of them and have the support of the community. Therefore, HRM, the Harbour Solutions Project team and the Councillor for the area, Steve Adams, will proceed to have a new group of representatives from the neighbourhood chosen through a transparent public process as the official CLC.

The CLC is a key group in ensuring community input and support for the Project. Therefore, the process that will be followed will involve a recruitment package, advertising, nominations, a selection committee and a public meeting. The timeline for recruitment of Herring Cove CLC is attached as Schedule "A"

Herring Cove Community Liaison Committee for Halifax Harbour Solutions Project Council Report - 3 - December 2, 2003

This process will ensure that there is ample and equal opportunity for all residents in the neighbourhood to offer their names as representatives on the CLC. The nomination process will provide for public input and result in a Committee with the skill sets and support to lead the community through the Project as it moves forward.
