5.1.1 Tax Structure Model

Andre MacNeil, Financial Consultant, gave a presentation to the Committee on Halifax Regional Municipality Tax Structure Model, detailing how the tax bill of a typical single family home in HRM is spent on municipal services.

The Committee agreed that this breakdown was very useful in helping the Committee understand how the municipal tax dollars are spent. They felt that this model or a similar model should be used at the next round of public consultations.

The Committee asked that staff provide an additional column showing the Commercial Tax bill breakdown.

Giselle Kakamousias, Committee Member, suggested that the next survey should include commercial as well as residential tax rate questions. These questions could ask residents how they feel about commercial tax, how it relates to residential tax and what should commercial tax cover.

The Committee thought that additional questions should be surveys fairly soon in order to be meaningful to the project. Questions should be submitted to Shannon Bennett and a quote will be obtained.

7.2 Verbal Update on replacement member for TRC

The Selection Committee is meeting on September 13th. Staff gave the Selection Committee a list of people who are still interested in sitting on the Committee.

It was suggested that an individual be selected to represent young professionals.
