# 7. REPORTS

# 7.1 <u>Tax Reform and Public Participation</u>

#### 7.1.1 Tax Reform - Public Participation - Staff Presentation

Bruce Fisher, Manager of Fiscal and Tax Policy, made a presentation to the Committee on Tax Reform - Public Participation. He explained the following:

- Tax Reform Decision Stages Principles, Foundations, Goals & Tools
- Sample Tax Reform Packages
- Details on Sample Packages
- Options for Consultations

Bruce Fisher noted that the Committee, at their last meeting, had requested additional sample packages. Three additional sample packages were added for this presentation. He continued by explaining the ten sample packages.

Staff were requested to provide a breakdown of revenue for services, by district.

# 7.1.2 <u>Tax Reform - Two Sample Packages</u>

Bruce Fisher, Manager, Fiscal & Tax Policy, provided the Committee with further details found in report 7.1.2 to help clarify two of the ten packages described in presentation 7.1.1.

A lengthy discussion took place on the number of options/packages that should be provided to the public at the time of public consultation and what the packages should be based on. The Committee discussed how the packages could be based on assessment, ability to pay, fee for service, dwelling unit charge for municipal services, general rate for core public services and charge for optional services. It was noted that urban/suburban/rural rates and residential/commercial rates should be incorporated into these packages.

The Committee requested Staff to provide a definition for "core public services" and show a sample package that would include core public services.

The Committee requested a copy of the Y2K and Pandemic reports which list municipal services provided by HRM.

Staff recommended that Andre MacNeil, Financial Consultant, present his report on the Allocation Model to help explain what drives these services.
